The undersigned declare, warrant and agree as follows:

That the undersigned is the owner of that certain real property described on the front of this card and hereinafter referred to as "property."

That the undersigned assumes responsibility for and guarantees payment of all charges and bills for water service, refuse removal and sewer service made by the City of Porterville for any of the above mentioned services supplied, delivered or used at said property and shall pay said bills and charges on demand.

That if the undersigned fails to pay said bills and charges the City of Porterville may, in addition to any other remedy of said City, include said bills and charges on any succeeding real property tax statement assessed to said property and may collect said bills and charges in the same manner as provided by law for collection of real property taxes and in the event said bills and charges are not paid at the time the real property taxes become due they shall become a lien on said property and may be collected in the same manner as provided by law for the collection of delinquent taxes.

The guarantee of payment of charges and bills for water service, refuse removal and sewer service is given pursuant to Section 25-8 of the Porterville City Code.
