City Council Reorganization

I. PURPOSE

To establish a process of reorganizing the City Council.

II. DISCUSSION

Annually, on the second meeting in March, the City Council reorganizes by selecting a new Mayor and Mayor Pro Tem.

III. PROCEDURE

The City Council will reorganize in the following manner:

A. Election of Mayor

1. The Mayor will turn the meeting over to the City Clerk who presides over the selection of the new Mayor.
2. The City Clerk states, "Nominations are now in order for the office of Mayor of the City of Signal Hill. Any member of the City Council may nominate any member for the position of Mayor. No second is required for the nomination."
3. The City Clerk states, "Councilmember _____ is nominated. Are there any further nominations for the office of Mayor?"
4. When it appears that no one else wishes to make a nomination, the City Clerk will state, "Are there any further nominations for the office of Mayor? If not, nominations are closed."
5. After completion of the nominations, the City Clerk provides each nominee with an opportunity to speak regarding his/her qualifications for the position.

6. The City Clerk then conducts a roll call vote for the selection of Mayor asking each member to vote for the nominee of his/her choice. The vote shall be conducted in alphabetical order.
7. The City Clerk then declares the result of the selection. The nominee receiving a majority vote of the City Council shall be declared the new Mayor.
8. Seats may need to be exchanged at this time.
9. After selection of the new Mayor, the City Clerk turns the meeting over to the newly elected Mayor, who is given an opportunity to make any remarks upon entering office.
10. The new Mayor presents a proclamation to the outgoing Mayor.

B. Election of Mayor Pro Tem

1. The new Mayor presides over the selection of the Mayor Pro Tem stating, "Nominations are now in order for the office of Mayor Pro Tem the City of Signal Hill."
2. The Mayor states, "Councilmember _____ is nominated. Are there any further nominations for the office of Mayor Pro Tem?"
3. When it appears that no one else wishes to make a nomination, the Mayor will state, "Are there any further nominations for Mayor Pro Tem? If not, nominations are closed."
4. The Mayor conducts a roll call vote for the selection of Mayor Pro Tem asking each Councilmember to vote for the nominee of his/her choice. The vote shall be conducted in alphabetical order.
5. The Mayor then declares the result of the selection. The nominee receiving a majority vote of the City Council shall be declared the new Mayor Pro Tem.
6. The Mayor provides the new Mayor Pro Tem an opportunity to make any remarks upon entering office.
7. Mayor resumes meeting.

City of Del Mar

POLICY #20

TITLE: Selection of Mayor and Deputy Mayor

POLICY:

Del Mar Municipal Code, Section 2.20.020 A and B, addresses when the City Council shall meet to install newly elected Council members and states that its members shall choose one of its members as Mayor and one of its members as Deputy Mayor by motion of the Council and three affirmative votes. It further states that the Mayor and the Deputy Mayor shall serve a term of one year, or until a successor for each position is chosen.

1. The Mayor and Deputy Mayor are members of the City Council and are annually elected by majority vote of the City Council at the first regular meeting in December or, in the case of an election year, upon certification of the election results. As a member of the City Council, the Mayor and Deputy Mayor shall have all the powers of a member.
2. In choosing the Mayor and Deputy Mayor, it is the tradition of the Council to place the top two vote getters in any one election into a queue to rotate into the position of Mayor and Deputy Mayor. In each City Council election, the person with the most votes shall be placed first in the rotation of that group, the second highest vote getter will be placed second, and in the years when there is a third seat contest, the third highest vote getter will be placed third in that rotation. However, the Council member who received the third most votes in an election year filling three seats will not be in the queue for either Deputy Mayor or Mayor but would be in rotation should the Council member traditionally rotating into the Deputy Mayor or Mayor position be unavailable to serve in that role.
3. In case of appointment to the City Council to fill a vacancy, that person will occupy the last position in the current rotation. Each new election will determine the rotation only for the group in that election. Should any City Council member not be available to take their regular place in the established rotation, the next person in the rotation will be elevated to the Deputy Mayor's position and the rotation will continue as previously set.
