27. GOVERNOR'S EXECUTIVE ORDER FOR STATEWIDE MANDATORY WATER REDUCTIONS, CONSIDERATION OF ADOPTION RESOLUTION FOR DECLARATION OF LOCAL EMERGENCY, AND RECONSIDERATION OF PROVISION OF WATER TO EAST PORTERVILLE RESIDENTS

Recommendation:

That the City Council:

- 1. Consider adoption of a Resolution of Declaration of Local Emergency; and
- 2. Consider Mayor Stowe's request to reconsider the County's request to purchase potable water for East Porterville residents.

City Manager Lollis introduced the item and presented the staff report. Following the report, staff addressed questions from the Council regarding the status of the water analysis and Akin and Beverly Grand water projects. The Council expressed frustrations with delays and concerns regarding the provision of water in light of those delays.

- Eric Lamoureux, Office of Emergency Services, Regional Director, stated that the State Department of Water Resources had committed to funding the well; addressed concerns regarding the progress made to date; spoke of the importance of moving forward in partnership and the declaration of emergency process; and requested provision of water to support the tank program.
- Bill Croyle, Department of Water Resources, Deputy Director for Statewide Emergency Preparedness and Security, communicated his agency's commitment to being part of the solution; spoke of drought management and drought resiliency; and stated that they were prepared to move quickly once a scope of services was available.

Both Mr. Lamoureux and Mr. Croyle addressed questions from the Council, and City Manager Lollis advised of a meeting to take place with regard to the agreement, scope of work, funding, and long-term agency commitments.

Andrew Lockman, Tulare County, spoke of the status of the City-County Agreement; stated that the County and City were conceptually in agreement with regard to the 100 water connections, and it was just a matter of putting it in writing.

City Manager Lollis advised of two City wells that were independent of the municipal water system, located west of town off of Olive Avenue; which could be an option should the Council approve the provision of water to East Porterville. He also spoke of the need to focus on tertiary treatment for the future and staff attendance at an upcoming funding fair.

COUNCIL ACTION: MOVED by Council Member Gurrola, SECONDED by Council

Member Ward that the City Council reconsider the Mutual Aid Request for the provision of water to East Porterville residents. The

motion carried unanimously.

COUNCIL ACTION: MOVED by Vice Mayor Hamilton, SECONDED by Council

Member Ward that the City Council approve the provision of water to County residents for a period of 30 days with a 500,000 gallon cap; authorize Acting Public Works Director Reed to cease the provision of water if needed; and approve the continued Declaration of

Emergency. The motion carried unanimously.

The Council briefly discussed those affected by the drought in East Porterville, and resources available to help educate and direct them towards services.
